

# IAFN Climate, Science, and Innovation Event Partnering 4 Betters Highlights

The FAO Strategic Framework 2022-31 has created the 'Four Betters'; better production, better nutrition, better environment, and better life, leaving no one behind, to guide the work of the organization towards the SDGs. To further private sector support for the Four Betters and to advance private sector work that is aligned with the FAO Strategic Framework, the International Agri-Food Network (IAFN) members convened an event with an emphasis on the FAO Science and Innovation and Climate Strategies as well as investment in SDG2.

The event was well attended with over 100 enthusiastic guests among which included Ambassadors and other senior representatives of Member States, UN agencies and the Private Sector. Special Guest Speakers at the event were Director-General of FAO, Dr QU Dongyu, Deputy Director-Generals of FAO, Beth Bechdol and Maria Helena Semedo and FAO Chief Economist Maximo Torero Cullen.

The event was held as a full one-day event allowing for active engagement of the Private Sector with Member States and representatives from the Rome Based Agencies.

Plenaries were held on science and innovation and on climate. Three workshops per theme allowed for deeper discussions and the exploration of ideas and initiatives, focused on furthering FAO's efforts in key areas. An investment café at lunch was held in preparation for FAO's Investment Forum.

A key outcome of the event was the announcement of the extension of the Accelerator Mentorship Programme for Women-led SMEs in Africa.

# **Key Points:**

- Private Sector has 3 scientists willing to serve from different sectors on the ATIO process.
- The private sector is open to exploring what kinds of information can be shared for the ATIO development. This needs to be made more concrete.
- If Chief Scientist organizes a foresight process-each sector, including animal health, digital agriculture, inputs, food inspection, and food technologists would supply experts to help the FAO.

- Participants then engaged in informal discussions over lunch. It is clear more information needs to be shared on the specific countries and opportunities for investment in Hand-in-Hand.
- Private sector representatives need to understand how to engage in the investment forum within WFF while gauging expectations of participation.
- The Investment process needs several levels of conversation, including de-risking and assessments of supply chains.

- Today's meeting with Private Sector provides a good example of transformation being undertaken by FAO to seek new ways of doing things to address climate change.
- Working together can bring synergies to have positive effect.
- There is a need to advocate at global, regional, country and community level for both adaptation and mitigation.
- Private Sector can foster innovation, investment in food systems to help reduce the climate impacts of food.

- Nutrition in the soil leads to nutrition in humans. Soil health has led to know-how and a capacity that farmers didn't have in the past, but changes made today lead to results 3-4 years later.
- Need to find how to compensate and stimulate farmers to steward soil.
- The ways forward with consumers are labelling and research.



- Carbon sequestration must be a win-win, for productivity to feed the most and sequestration for the environment. Soils must feature more prominently in climate plans and policies.
- Private sector must manage trust by ensuring data is transparent and guaranteed by third parties.

- Institutionalise discussions between FAO, private sector, and farmers specifically, across the broadest possible spectrum of spaces.
- FAO is working across all dimensions to move the needle on bioeconomy. It requires countries to come together and build inter-stakeholder collaboration. Investment in the bioeconomy and circularity is needed.
- FAO was encouraged to ask farmers what they need more often.
- As in the soils session, it became clear carbon sequestration and soils is a fundamental task that underpins the bioeconomy.
- There was an agreement in principle to do some joint convening with farmer groups,
   IAFN, and the FAO bioeconomy team to share more knowledge.
